### Introduction

This report provides a comparison of the data from 1<sup>st</sup> April 2017 to 31<sup>st</sup> December 2017 and to the same period in previous years where relevant. The period 1<sup>st</sup> April 2017 to 31<sup>st</sup> December 2017 will be referred to as Quarter 3 or Q3 for the remainder of the document.

Please note: this report contains information on incidents within the Tyne and Wear Service area only and the incidents that were marked "checked" in the IRS on 8 January 2018.

The sickness data contained in this report is based on information submitted to HR up to 8 January 2018.

This report also refers to "risk levels" which is the level of risk attached to the mobilisation category selected at the time of call. Risk level one incidents are those that are deemed to have a high level of risk to human life; risk level two incidents have a moderate level of risk to human life; risk level three and four incidents are those that have a low or minimal level of risk to human life.

### **Executive summary**

To the end of quarter 3 2017/18 in comparison to quarter 3 2016/17:

### **Deaths and Injuries**

- There have been 3 fire fatalities (LI02) within the Service area.
- There has been a 5% (7) increase in the number of injuries from all fires (LI05).
- There has been 10% (3) fewer injuries from accidental dwelling fires (LI03).
- 39% (11) of the victims who went to hospital were aged between 35 and 64 (LI03).

#### **Fire Attendances**

- We attended 29% (1378) more fires within the Service area (LI24).
- There has been a 43% (921) increase in deliberate refuse fires (LI18).
- There has been 10% (26) fewer accidental kitchen fires (LI09).
- There has been a 46% (1299) increase in deliberate secondary fires (LI16).

### **False Alarms**

- There has been a 1% (17) increase to AFAs in a non domestic premises (LI22).
- There has been a 6% (120) increase to AFAs in a domestic premises (LI23).
- 45% (916) of domestic AFAs were due to cooking or burnt toast (LI23).
- There has been 17% (49) fewer false alarms to 'hospitals and medical care' premises. The lowest recorded since 2009/10.


### **Management Indicators**

- There has been a 17% (1964) increase in the number of incidents (LI32).
- 24292 home safety checks have been successfully delivered.
- Targeted Response Vehicle's (TRV) attended 22% (3093) of the incidents within Service area (LI36).
- 58% of TRV attendances are between 17:00 and 22:00.
- There has been a 18% (29) increase in fires in non domestic premise (LI35).
- The average attendance time to a risk level one incident was 5 minutes and 09 seconds (excluding TRVs).

### LI Overview 2017/18

Of the 16 priority local performance indicators it is forecasted that TWFRS will attain six (38%) targets (LI03 - Injuries from accidental dwelling fires (excl. precautionary check and first aid), LI05 - Injuries from all fires, LI08 - Accidental dwelling fires, LI09 - Accidental kitchen fires in dwellings, LI10 - Accidental non kitchen fires in dwellings, LI22 - Alarm calls to AFA from non domestic premise).

# Deaths and injuries (LI01, LI02, LI03, LI05) Key facts



### Gateshead

Unfortunately, Gateshead has recorded 1 (August) fatality in a 'car'. There have been 33 injuries across 23 incidents from all fires, an increase of 8 injuries (32%) and 3 incidents (15%).

# • 75% (21) of the incidents where a victim or victims attended hospital the room of origin of the fire was the kitchen (LI03).

- In 79% (22) of the injuries where the victim or victims attended hospital, the injuries appeared to be slight (LI03).
- There has been a 5% (7) increase in the number of injuries from all fires (LI05).
- There were 139 victims from 112 fires where there were victim(s) involved (LI05).
- Where an occupancy type has been recorded, 72 were 'Lone person/parent' (LI05).

#### Newcastle

There have been 39 injuries across 34 incidents from all fires, an increase of 3 injuries (8%) and 6 incidents (21%). There has been a reduction of 2 injuries from accidental dwelling fires with no change in the number of incidents (9).

#### **North Tyneside**

There has been a decrease of 1 in the number of injuries from all fires to 19. There have been 4 injuries across 4 separate incidents from accidental dwelling fires, an increase of 3 in the same period last year (1 injury from 1 incident).


#### **South Tyneside**

There have been 14 injuries across 13 incidents from all fires, an increase of 2 incidents (18%) and 3 injuries (27%).

#### Sunderland


Unfortunately, Sunderland have recorded 2 fatalities, 1 (May) in 'House – single occupancy' and 1 (August) in 'car'. There has been a reduction of 23% (10) in the number of injuries from all fires to 34, 7 of which are accounted for in accidental dwelling fires where there were 7 injuries from 6 incidents.







LI01 - Number of deaths from accidental fires in dwellings



LI05 - Injuries and incidents from all fires





### Fire attendances (LI08, LI09, LI10, LI16, LI33, LI18, LI24, LI29) Key facts



- 24% (345) of primary fires had a property type of 'Car' (LI29).
- 2% (10) increase in deliberate primary road vehicle fires (LI29).
- 43% (921) increase in deliberate refuse fires (LI18).
- 40% (1367) increase in deliberate fires (LI33).
- 6% (11) fewer accidental dwelling fires which did not start in the kitchen (LI10).

### Gateshead

There were 1092 fire calls, an increase of 16% (157). 78% (854) of these were deliberate. 89% (760) of all deliberate fires are secondary fires. Accidental dwelling fires have decreased by 19% (16) to 69.

#### Newcastle

There were 1896 fire calls, an increase of 44% (578 incidents). Of these, 1477 (78%) were deliberate fires, an increase of 49% (489 incidents). Deliberate secondary fires account for 86% (1275) of all deliberate fires in Newcastle. Accidental dwelling fires have seen an increase of 12 incidents (10%).

#### **North Tyneside**


There has been a 12% (66) increase in fires attendances (617 in total). Deliberate fires have increased by 24% (83) to 434. 80% (346) were deliberate secondary fires which have increased by 29% (78). Accidental dwelling fires have decreased by 26% (21) and non-kitchen fires decreased by 9 incidents (27%).

### South Tyneside

There has been a 17% (87) increase in fire attendances to 605 incidents. Deliberate fires have increased by 32% (109) to 447, 85% (379) of which were deliberate secondary fires. There has been a 13% (7) decrease in accidental dwelling fires.


### Sunderland

There has been a 35% (493) increase in fire attendances to 1893 incidents. Deliberate fires have increased by 48% (519) to 1600. 87% (1393) are deliberate secondary fires. Accidental dwelling fires have decreased by 5% (5).




LI08 - Accidental fires in dwellings by district year on year




## LI10 - Accidental non kitchen fires in dwellings by district year on year





### Gateshead

### Newcastle

AFAs from non domestic premises have increased by 4% (22). 'Hospital and medical care' account for the majority with 16% (101). Domestic AFAs have increased by 8% (76). 50% (495) occur in purpose built flats/maisonettes and 32% (314) in sheltered housing.

### North Tyneside















LI22 - Non domestic false alarms year on year


LI22 - Non domestic false alarms by district year on year
