# RESPONSE

 We are exempting this information under section 43(2) of the Freedom of Information Act. Section 43(2) is a qualified exemption and is subject to public interest testing which means that the information requested can only be withheld if the public interest in doing so outweighs the public interest in disclosure.

Section 43(2) has been applied because the information in scope of the exemption would affect the commercial interests of SFJ Awards. The winning bid contains confidential information and the release of the detailed bid would negatively impact on the awarded supplier, inline with the Public Contract Regulations (PCR20150 and best practice, an award notice was released on Contracts Finder (End Point Assessment Organisation - Contracts Finder). Release of information could also prejudice relations between Tyne and Wear Fire and Rescue Service and its suppliers. For these reasons I have set the level of "would" rather than "would be likely to".
